



## Declaration Form for Visitors Tax for Annual Lump Sum Rate for owners of apartments and chalets

Based on the Visitors Tax –Regulations of the Municipality of Lauenen, all natural persons, not having their domicile and taxable income declared in the Municipality of Lauenen, who spend a night in the Municipality of Lauenen are liable to pay visitors tax (Vtr Art. 3). Owners, beneficiaries and permanent tenants of apartments and holiday apartments, holiday chalets, private rooms, mobile homes and caravans will pay the visitors tax in the form of an annual flat rate.
