## **GENERAL TERMS AND CONDITIONS OF CONTRACT**

### **1. Implementation**

In November you will receive your annual statement from Gstaad Saanenland Tourismus (GST) along with all the anticipated event dates scheduled for the resort, together with information on when the advance ticket sales are due to begin, how to secure tickets, and how your sponsorship funds are to be used. The organisers of these top events will then personally get in touch with the Supporters, make the relevant seat reservations, and provide all the event services included in the Sponsoring Package. Some of the event tickets are transferable or can be issued to a person of the Supporter's choosing. An upgrade to a higher ticket category can be requested from the event organisers (subject to payment of the difference in price).

All extra services (Add-ons) will be sent out by post along with the annual statement.

### **2. Right to the acquisition of services**

The member shall be entitled to a full and comprehensive provision of the services to which they are entitled according to the specifications of their Sponsoring Package, providing said member observes the terms and conditions of acquisition set out for these services by the individual organisers and institutions. The member shall not be entitled to compensation for any services they fail to acquire.

### **3. Duty to inform**

Gstaad Saanenland Tourismus and the beneficiary service partner undertake to keep the member informed fully and in a timely manner. They shall ensure that the member is able to acquire the services they request in accordance with the Terms and Conditions of the Contract (i.e. timely dispatch of ordered tickets, invitations, etc.).

### **4. Liability for damages in the event of force majeure**

Should an event be unable to provide its service either in full or in part due to force majeure, neither Gstaad Saanenland Tourismus nor the event in question shall be liable.

### **5. Possibility of changes to the Service Package**

The content of the Service Package and/or its price may be amended or adjusted by Gstaad Saanenland Tourismus on January 1 of each year. The member shall be informed of the changes at least one month before the period of notice is due to expire.

### **6. Transferability**

Elements of the Service Package (e.g. season tickets) may be transferred to natural persons of the member's choosing. Such elements of the Service Package may only be issued to companies – i.e. not to natural persons – if expressly authorised by the Service Partner concerned.

### **7. Terms and conditions of payment**

The annual membership subscription shall be invoiced at the beginning of each year (payable within 30 days).

### **8. Commencement of the Contract / Termination**

The membership is concluded between the member and Gstaad Saanenland Tourismus and shall take effect on January 1. It is concluded for an indefinite period and may be terminated on December 31 of any year subject to three months' notice. Early withdrawal from the Contract before December 31 is not possible even if the member has not acquired any of the services.

### **9. Joining during part of the year**

Should a member sign up for membership after January 1, said member shall not be entitled retrospectively to any services.

### **10. Contact / Management**

Gstaad Saanenland Tourismus is the contact and management agency for all questions and issues relating to the Gstaad Events Supporter Club.

### **11. Passing on of addresses**

Gstaad Saanenland Tourismus shall be entitled to pass the member's address on to the beneficiary events and institutions.

### **12. Applicable law / place of jurisdiction**

Any points not specifically regulated in the general provisions shall be governed by the Swiss Code of Obligations. The place of jurisdiction is CH-3792 Saanen.
